

**RESOLUTION AND ORDINANCE  
FISCAL YEAR 2020-2021 BUDGET  
CITY OF CONCORD, GEORGIA**

**WHEREAS**, pursuant to Title 36 Chapter 81, of the Official Code of Georgia Annotated, and section 2-5-2 of the Code of Concord, Georgia, the City Council of Concord, Georgia, as the governing authority of said city, shall adopt an annual balanced budget; and,

**WHEREAS**, a balanced budget for Fiscal Year 2019-2020, beginning August 1, 2020, and ending July 31, 2021, has been submitted to the City Council by the Mayor and,

**WHEREAS**, the City Council has reviewed said proposed budget and revised and amended same as the Council deemed advisable and necessary; and,

**WHEREAS**, the entire budget has been available for public inspection and a public hearing has been properly advertised and held as required by Georgia law;

**NOW, THEREFORE, BE IT RESOLVED AND ORDAINED** by the Council of Concord, Georgia, as the governing authority of said City, that a Budget Ordinance of Concord, Georgia for Fiscal Year 2021 be adopted upon approval at two (2) public meetings of the City Council as follows:

**Section 1: General Fund**

A. It is estimated that the following revenues will be available in the General Fund for the fiscal year beginning August 1, 2020 and ending July 31, 2021:

Taxes	160,248
Licenses & Permits	425
Franchise Fees	14,600
Interest	450
Other Revenues	<u>38,150</u>

B. The following amounts are hereby appropriated in the General Fund for the operation of the city government and its activities for the fiscal year beginning August 1, 2020 and ending July 31, 2021:

City Expenses	124,085
Street Department Expenses	<u>89,788</u>

## Section 2: Concord Utilities

- A. It is estimated that the following revenues will be available in Concord Utilities for the fiscal year beginning August 1, 2020 and ending July 31, 2021:

## Section 3: Capital Improvements Water Fund

## Section 4: Capital Improvements General Fund

## Section 5: Other Stipulations


- A. The Mayor is hereby authorized to transfer appropriates within a fund as contained herein under the following conditions:
1. He may transfer amounts between objects of expenditure within a department without limitation and without a report being requested, except that transfers of appropriations within a department which increases the salary appropriation shall require the approval of the City Council.
  2. He may not transfer any amounts between funds nor from any contingency appropriations within any fund without action of the City Council.
- B. The Mayor shall have the authority to deny payment of City funds for any expenses for which an appropriation is not made or which exceeds the appropriated amount for a specific item or purpose, unless such expense is approved by the City Council. In such event of denial of payment of city funds, the city officer or department head that shall incur, authorize or approve such expense, either directly or indirectly, shall be solely and personally responsible for the payment therefore.
- C. Nothing contained in this ordinance shall prohibit the City Council, as the governing authority, from amending the budget as appropriate or necessary during the fiscal year.
- D. A line-item budget shall be bound for retention, and copies of the line-item budget shall be available for public inspection at the office of the City of Concord during regular business hours.
- E. All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed. The Budget Ordinance of Fiscal Year 2019-2020 is hereby repealed, effective at 12:00 AM on August 1, 2020.
- F. This Ordinance shall become effective at 12:00 AM on August 1, 2020 or immediately upon adoption if after 12:00 AM on August 1, 2020 and together with any amendments hereto, shall remain effective until midnight on July 31, 2020 until repealed.
