### RESOLUTION 2019-002

A RESOLUTION TO ADOPT A NEW WATER AND WASTEWATER SCHEDULE OF RATES; TO AUTHORIZE FILING OF THIS RESOLUTION; TO REPEAL INCONSISTENT RESOLUTIONS; TO ESTABLISH AN EFFECTIVE DATE; AND FOR OTHER PURPOSES

#### WITNESSETH:

WHEREAS, The City of Concord, Georgia ("City") is a Municipal Corporation duly organized and existing under the laws of the State of Georgia; and

WHEREAS, by virtue of Section 1.13, Subsections (9) and (25) of the City Charter, the City is authorized to operate public utilities, and to fix the rates, charges, fee assessments, connection fees, regulations and penalties for same; and

WHEREAS, the schedule of water and sewer rates are set by the Mayor and City Council from time to time and kept on file in the office of the City Clerk; and

WHEREAS, the City Council believes that it is time to adjust the water and sewer rates in the City and to adopt a new schedule of rates.

## THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CONCORD, GEORGIA, AS FOLLOWS:

- 1. Approval of Water and Wastewater Rates Schedule. The City of Concord Water and Wastewater Rates schedule attached hereto and incorporated herein by reference as Exhibit "A" is hereby adopted and approved by the City Council for the City of Concord as the City's schedule of rates.
- 2. Due Authorization; Recording. The Mayor is hereby authorized to execute and record any and all documents necessary to file and effectuate this Resolution. The City Clerk is hereby directed to record this Resolution in the official minutes of the City.
- 3. Severability. To the extent any portion of this Resolution shall be held invalid or unenforceable, that shall not affect the validity or enforceability of the remaining portions of this Resolution.

- 4. Effective Date. This Resolution shall take effect on August 1, 2019.
- 5. Repeal of Inconsistent Provisions. All resolutions are hereby repealed to the extent they are inconsistent herewith.
